When obtaining consent from a representative of the subject of personal data

in accordance with Art. 9 of Federal Law No. 152-FL "On Personal Data", para. 1 of Art. 64 of the Family Code of the Russian Federation, I give consent to JSC "UK Hotel Management", INN 7709656042, located at 24 Rusakovskaya St., Moscow (hereinafter referred to as the Company, Operator) in accordance with parts 1, 4 of Art. 9, part 1 of Art. 11 of the Federal Law of July 27, 2006 No. 152-FL "On Personal Data" freely, by my will, **in my interest / in the interests of the child** (underline as necessary) for processing **my / child's** (underline as necessary) following personal data, namely:

last name, first name, patronymic, gender, year, month, date and place of birth, citizenship, passport data (data of another document certifying identity in accordance with the legislation of the Russian Federation), address of registration, phone number, email address, bank card data, information on issued visas/migration cards, current registration; information on crossing the state border; data on consent for accommodation of persons under 18 years old in the hotel; biometric personal data (photographic image).

Purpose of processing personal data:

ensuring compliance with laws and other regulatory legal acts in the implementation of migration registration of citizens at the place of stay; identification of the subject of personal data; booking arrangements; receiving feedback from the subject of personal data on the quality of services provided; carrying out payment and banking operations; preparation of primary accounting documents accompanying the provision of services; settlement of possible disputes and claims.

I grant the Company the right to perform all actions with personal data, including collection, systematization, accumulation, storage, updating, modification, use, anonymization, blocking, and destruction. The Company has the right to process personal data both in non-automated and automated ways by entering them into an electronic database.

I agree with the transfer of personal data by the Company to: the Federal Migration Service of the Russian Federation - for migration registration; for conclusion and execution of contracts by the Company with third parties: PJSC "VTB" (INN 7702070139), JSC "Bank Russkiy Standart" (INN 7707056547) - banking operations; PJSC "VimpelCom" (INN 7713076301) - communication services; JSC "Alfa Insurance" (INN 7713056834) - civil liability insurance, for recovery of damages caused to the Company by the subject of personal data.

I establish a prohibition of the transfer of biometric personal data, except for their transfer to the Federal Migration Service of the Russian Federation.

This Consent is valid for 5 (five) years from the date of its signing. I reserve the right to withdraw my Consent by submitting a written statement. In case of receipt of my written statement on withdrawal of this Consent for processing personal data, the Company is obliged to stop their processing, unless otherwise provided by the applicable legislation of the Russian Federation
