I prohibit the transfer of biometric personal data, except for its transfer to the Federal Migration Service of the Russian Federation.

This Consent is effective for 5 (five) years from the date of its signature.

I reserve the right to withdraw my consent by providing a written statement. Upon receipt of my written statement revoking this Consent to the processing of personal data, the Company is obliged to terminate their processing, unless otherwise provided by the current legislation of the Russian Federation.
